



NAEYC Teaching Staff Survey for Self-Assessment

This survey is part of program self-assessment for accreditation by the National Association for the Education of Young Children (NAEYC). Teaching staff perspectives are essential to the NAEYC Accreditation process. To achieve accreditation, programs must provide opportunities for teaching staff to participate in the self-assessment and program improvement process. Programs must provide all members of the teaching staff the opportunity to respond confidentially to this survey; at least 80% of all teaching staff must return the survey for the results to be considered valid. It is important to remember the definitions of teaching staff (below) used in this survey. Unless specifically stated, all teaching staff answer all questions, even if they are not responsible for the work addressed in the statement. For example, question 1 says "teachers" work with the family. For an Assistant Teacher or Teacher Aide, the answer should be based on whether the classroom's Lead teacher meets this statement.

Teachers: Adults with primary responsibility for a group of children.

Assistant Teachers or Teacher Aides: Adults who work under the direct supervision of a teacher.

Teaching Staff: All members of the teaching team, including teachers and assistant teachers/aides.

Program Staff: May be members of the teaching staff, support staff, and/or administration

For each statement, circle "Yes" or "No" or "DK" for "don't know." If the statement does not apply to your program, circle "NA for "not applicable."
